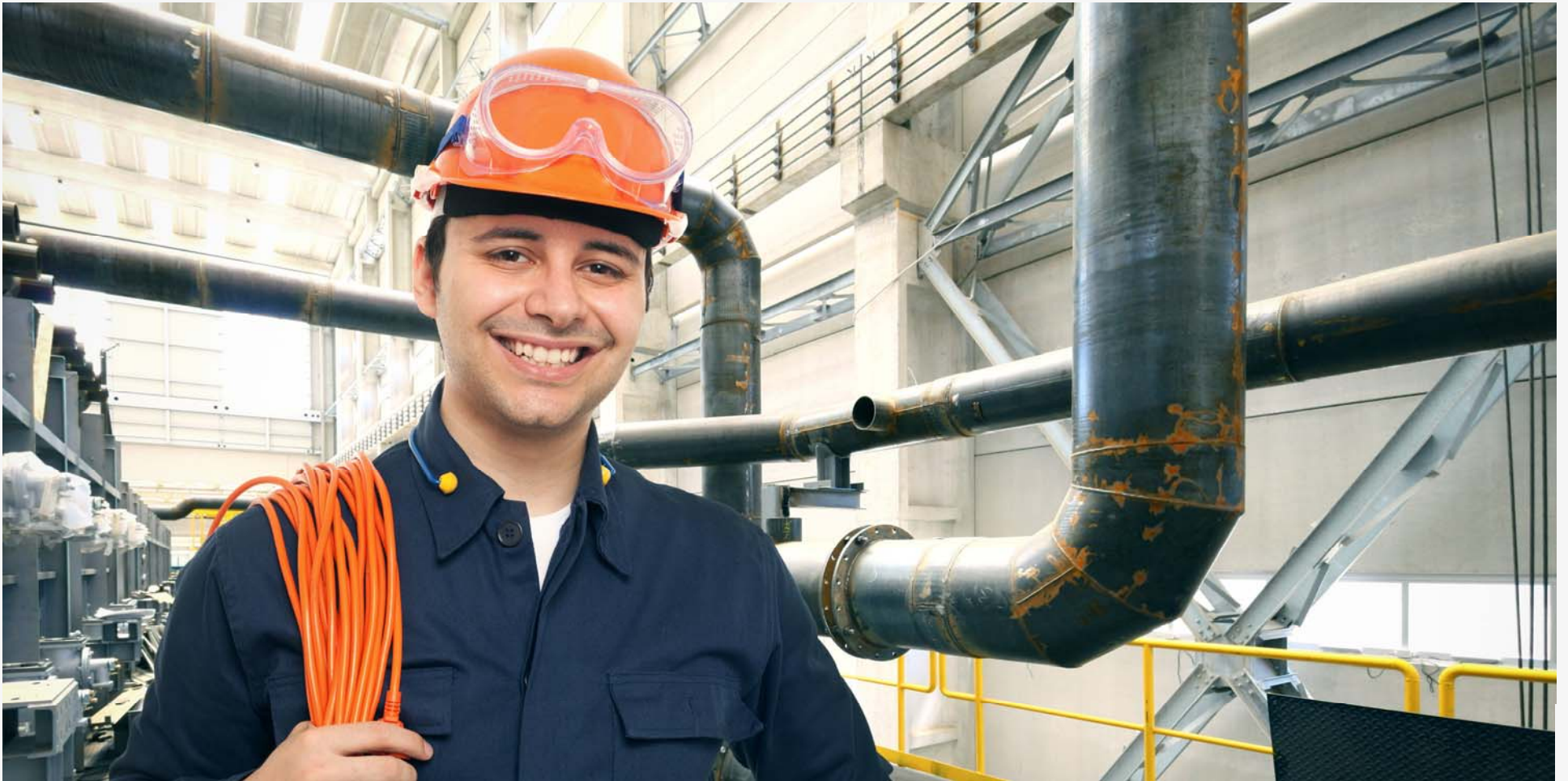




## DENTAL OPEN ENROLLMENT

YOUR DENTAL BENEFITS ARE CHANGING ! JUNE 1<sup>ST</sup> THRU JULY 31<sup>ST</sup>



### DELTA DENTAL HMO

- A CALENDAR YEAR MAXIMUM WILL NOT APPLY AND ALL PROCEDURE LIMITATIONS WILL BE RESET EFFECTIVE SEPTEMBER 1, 2018.
- A DENTAL DEDUCTIBLE WILL ALSO NOT APPLY.
- SERVICES MUST BE PROVIDED BY YOUR ASSIGNED DELTACARE USA DENTIST, WHICH YOU MAY CHOOSE FROM THE NATION'S LARGEST DENTAL HMO NETWORK.
- THE BENEFIT SCHEDULE WILL BE NEARLY IDENTICAL TO THE CURRENT CIGNA DENTAL HMO SCHEDULE.
- FOR BASIC ORTHODONTIA, UP TO 24 MONTHS OF TREATMENT ARE COVERED AND REQUIRE NO MEMBER COPAYMENT.

### DELTA DENTAL PPO

- THE \$1,800 CALENDAR YEAR MAXIMUM WILL CONTINUE TO APPLY, ALTHOUGH THE CALENDAR YEAR MAXIMUM AND ALL PROCEDURE LIMITATIONS WILL BE RESET EFFECTIVE SEPTEMBER 1, 2018.
- THE \$50 DENTAL DEDUCTIBLE WILL ALSO CONTINUE TO APPLY, BUT WILL NO LONGER COUNT TOWARDS THE \$250 MEDICAL DEDUCTIBLE.
- ACCESS TO DELTA DENTAL'S PPO NETWORK OF CONTRACTED DENTISTS, PREVENTING ANY BALANCE BILLING.
- BASIC, DIAGNOSTIC, PREVENTIVE, AND ORTHODONTIA SERVICES WILL BE PAID AT 100%, WITH MAJOR SERVICES PAID AT 90% OF THE PPO CONTRACTED FEE.
- FOR ORTHODONTIA, THE \$600 ANNUAL MAXIMUM WILL NO LONGER APPLY, THE \$1,800 MAXIMUM WILL BE RESET EFFECTIVE SEPTEMBER 1, 2018 AND PAYMENTS WILL BE TREATED AS A SEPARATE ALLOWANCE.
